Project Eligibility

- * Projects must be completed between January 1 and December 31. Program application must be submitted to the participating Ohio electric cooperative by no later than December 31.
- * All qualifying insulation and air sealing upgrades must be installed in an electrically heated residential home which receives its electric power from a participating Ohio electric cooperative (that receives power for this facility from Buckeye Power) and meet all other requirements of this program.
- * Applicants must own the residence and be the homeowner of record. Only one rebate is permitted per residence.
- * All projects must be a retrofit installation in an existing residential home. Program is not applicable for new construction or room/home additions or expansions.
- * Rebate is for attic or exterior wall insulation or air sealing upgrades only. Installations that are NOT ELIGIBLE for a rebate include the following: new construction, new residential additions, garages, sheds, workshops, insulating doors, sound proofing applications.
- * For insulation rebate, contractor must follow ENERGY STAR guidelines and achieve minimum R-20 for walls, R-38 for attic and/or R-6 for duct insulation.
- * Insulation and air sealing upgrades must be installed by a licensed contractor. Do-it-yourself insulation and air sealing upgrade projects are not eligible for this rebate.
- $\ensuremath{^*}$ All projects must comply with applicable federal, state and local laws and building codes.

Documentation

- * A blower door test is required for all air sealing projects. Final test results after air sealing upgrade must achieve < 4,000 CFM50 to be eligible for rebate.
- * All applications must be complete and include an itemized contractor invoice in order to be considered. Incomplete applications will not be processed.
